

JOY IN GIVING BACK

Donor Joy Barr



Anne DiGiacomo and Joy Barr, Fiesta Gala at the Turning Stone Resort Casino Joy Barr first came to St. Joseph's Health Hospital in 2003, referred by her own physician in Ithaca, NY, to see vascular surgeon Lawrence Semel, MD. "He had to put a whole new carotid artery in my neck," says Barr. "He really saved my life."

Barr was so impressed with the care she received, she has remained a patient of Dr. Semel for 20 years, even though she could now receive follow-up care closer to home.

"St. Joseph's has a nice way of doing things; it's very personal," she says. "Other hospitals could learn from them."

More recently, when Barr needed a hernia removed, she chose to come to St. Joseph's to be treated by general surgeon Balasubramaniam Sivakumar, MD, better known as Dr. Kumar.

"I feel comfortable there and know I am going to receive great care," says Barr.

That's why Barr has chosen to support St. Joseph's Health Foundation financially, earmarking her gifts toward the Department of Vascular Surgery in honor of Lawrence Semel, MD, and the Department of General Surgery in honor of Dr. Kumar.

In addition, she sponsored both a patron table at this year's gala dinner dance and the masters foursome for the annual golf classic. "I feel really good about it," she says of supporting St. Joseph's.

Barr, now 83, grew up in Sudbury, Ontario, where she became a competitive ice skater. She was recruited to Cornell as a skating instructor in 1960 by the hockey coach at that time, Paul Patton, and former athletic director, Bob Kane. She served for years as a skating instructor in the Cornell Physical Education department and oversaw everything skating related for the university, even instructing the hockey players in power skating.

In the beginning, Barr would perform skating routines between periods of the Cornell men's hockey games. "My mother was horrified," she recalls.

After one game, a young man invited her to come home with him to a cocktail party his parents were having that evening. "I told him I'd need two weeks advance notice for a date," says Barr. "I figured I'd never hear from him again."

But David Barr, a third-generation Ithacan, was persistent. The couple married and had two children. David's family was in the brokerage business, with a seat on the New York Stock Exchange. The couple supported non-profits that made a difference in their lives, including Cayuga Medical and Ithaca College, David's alma mater.

David died in 2017 and Barr says, six years later, she has finally adjusted to life on her own. "Every day is a new adventure," she says. "I get up and put two feet on the ground and think, good, I've got another day ahead of me. I'm happy."





THE GRANTS OFFICE AT ST. JOSEPH'S HEALTH RAISED MORE THAN \$2.5 MILLION IN FY23

IMPROVING BEHAVIORAL HEALTH FOR THOSE WE SERVE \$483,848

St. Joseph's Health Foundation received a \$15,000 grant award from the **Flora Bernice Smith Foundation** to provide evidenced-based traumainformed resources and training opportunities for frontline behavioral health workers – enhancing mental health care and better preparing clinicians to help address issues such as alcohol or drug dependence, self-harm, eating disorders, suicidal behavior, depression, anxiety, alcoholism, and opioid use.

With the aim of coordinating behavioral health crisis response services, the **New York State Office of Mental Health** (NYS OMH) awarded \$25,000 to St. Joseph's Hospital Health Center for Round 2 of the Mobile Crisis Program Services grant. This program works to reduce behavioral health symptoms for individuals of all ages, restore them to their pre-crisis level of functioning, make connections with community supports, and/ or secure access to a higher level of care when needed. Funds from this grant were used to purchase two vehicles for use by the Mobile Crisis Program team as they provide crisis services in the community.

To support retention efforts through professional development, the **Onondaga County Department of Children and Family Services** awarded a \$10,000 grant to St. Joseph's Health Hospital. These funds will be used to provide behavioral health colleagues with continuing education, evidencebased practice, and reimbursement for fees for obtaining or renewing a professional license. The Onondaga County Department of Children and Family Services awarded \$258,000 to St. Joseph's Health Hospital for the Hospital's psychiatric emergency room to partner with Liberty Resources and Helio Health to provide crisis services as part of a response team for the County's 911 Diversion Crisis Service pilot program.

St. Joseph's Hospital Health Center received \$175,848 from the **Onondaga County Department of Children and Family Services** which will be used to reduce avoidable visits to the psychiatric emergency room and inpatient admissions and provide evidence-based training opportunities for frontline staff who provide mental health care through St. Joseph's Outpatient Behavioral Health Clinics, Personalized Recovery Oriented Services (PROS), and Residential services.



The **Central New York Library Resource Council** (**CLRC**) awarded a \$3,100 grant to St. Joseph's College of Nursing to be used to expand library collections, databases and/or technology. This CLRC grant is awarded through the New York State Hospital Library Services Program.

The **New York State Education Department** provided \$4,494 in Library Collection Aid for St. Joseph's College of Nursing. State aid helps to expand library offerings such as textbooks, software, and other library materials, as well as computer hardware and equipment. To enhance supports and services for students with disabilities enrolled at St. Joseph's College of Nursing, the **New York State Education Department** awarded a \$1,310 grant to be used to create an environment where students feel included. Funds purchased materials/supplies to help mitigate general and/or test anxiety and offer a warm, safe space for students; art therapy supplies and other materials to be used to de-stress and relax; and professional development for faculty and staff so they remain up to date in their field and can positively impact the educational experience for all students, including students with disabilities.

A FOCUS ON COMMUNITY HEALTH **\$750,000**

A \$750,000 grant award from the Mother Cabrini Health Foundation supported the expansion of St. Joseph's Food Farmacy. Based on lessons learned from its inaugural year in 2020, the program's second year focuses on collaborative work with community partners toward reaching a greater number of individuals experiencing food insecurity, chronic conditions, and limited access to health care. The program accepts patients with at least one chronic health condition who are also experiencing food insecurity. Program participants work directly with a Registered Dietitian and a Community Health Worker to receive Medical Nutrition Therapy and other nutrition education. Meals are also provided, helping to improve the availability of healthy food options. Also, a Community Health Worker assists program participants with identifying and accessing social care resources. Another feature of the enhanced Food Farmacy program is the creation of a network of community-based organizations (CBO) that are committed to serving at-risk individuals and supporting those with chronic health conditions by screening for food insecurity, providing social support, and assisting with transportation needs, unemployment, and other social determinants of health. CBO partners include Brady Market, Dunbar Association, Syracuse Northeast Community Center, and Westcott Community Center, all of which serve community residents who live in pockets of poverty within the City of Syracuse.



EMERGENCY RESPONSE AND PREPAREDNESS \$1,321,840



In accordance with directives issued by the NYS Department of Health and Governor Cuomo (Executive Order No. 202.10), NYS's response to the coronavirus pandemic required hospitals across the State, including St. Joseph's and its facilities, to remain open and provide continuing and expanded health care services. In response, St. Joseph's implemented and expanded emergency protocols to protect the health of its workforce and patients from COVID-19 infection and to prevent the spread of the disease within its facilities. Under a nationwide emergency declaration for COVID-19, and subsequent disaster declarations for COVID-19, eligible nonprofit organizations that lost revenue and faced higher expenses related to the declared emergency can apply for reimbursable expenses related to emergency readiness and response activities through the Federal Emergency Management Agency (FEMA) Public Assistance program. St. Joseph's Hospital Health Center was the recipient



of \$1,281,840 in COVID-19 Pandemic relief funds through this FEMA initiative aimed at providing support in meeting emergency needs during the Pandemic, specifically for those critical actions necessary to save lives and protect public health and safety. Examples of covered expenses included the purchase of personal protective equipment such as masks, face shields, goggles, and gloves; hand-held temperature scanning devices; disinfectant supplies and equipment; and signage for disseminating public information on health and safety measures.

A \$40,000 Hospital Preparedness grant from **Health Research, Inc**. was awarded to St. Joseph's Hospital Health Center to provide training, disaster exercises, service coordination, and a process improvement feedback mechanism to enhance the ability to respond to large-scale local and regional disasters.

VOLUNTEERS TEEN VOLUNTEERS GAIN AS MUCH AS THEY GIVE IN SERVICE TO HOSPITAL

St. Joseph's Health Hospital benefits from the time and talent of dozens of volunteers who donate their energies to helping the Hospital run at its best, from greeting patients as they enter to making deliveries, to transporting patients. Each summer, the Hospital receives an added bonus through its Teen Volunteer Program.

"Prior to the COVID-19 pandemic, we welcomed about 100 teen volunteers each summer," says Mary Hagen, coordinator of volunteer services. "I've been purposefully rebuilding the program, and this past summer we had 70."

Hagen says high school students choose to volunteer at the Hospital for a variety of reasons—to fulfill volunteer hours for National Honor Society, to bolster college applications, or to explore an interest in health professions.

"We have students who return year after year," she says. "And once a student has been a summer volunteer, they are able to volunteer during the school year if they're interested."

Maria Sadek, a senior at Fayetteville-Manlius High School, applied for the summer volunteer program two years ago because she hoped the experience would help define her interest in pursuing a medical career. Her experiences through the program have not only made her look at medicine differently, but the world around her. "No matter who you are or where you come from, the Hospital welcomes you," she says. "This should be universal, but I feel it's especially well represented at St. Joseph's."

Sadek says that welcoming atmosphere rubbed off, and she now finds herself offering a more hospitable attitude toward strangers. "This will help me in my future endeavors, potentially as a clinical pharmacist, as people realize I am approachable," she says.

Trisha Adavikolanu, also a Fayetteville-Manlius senior, says her perception of volunteering at the Hospital was much different than the reality. "For some reason, I believed I'd be helping surgeons in the operating room or be transporting an organ for donation", she says. "My first day, I spent in the supply chain, moving around boxes while taking 15-minute popsicle breaks."

After her first week, she thought of her volunteer tasks as seemingly trivial. But over the course of weeks and years, she realized it was those seemingly trivial tasks that allowed the Hospital to run with such success and deliver excellent care to patients.

Adavikolanu notes that what she was witnessing and experiencing was compassion. "St. Joseph's helped me realize my true desire in life: to be in the health care profession and share the same compassion I have experienced in this hospital," she says.

ST. JOSEPH'S COLLEGE OF NURSING

Dedicated to Educating and Inspiring Students



The COVID pandemic necessitated changes in St. Joseph's College of Nursing. Limitations in class size and in-person gatherings; on-line or remote classes; restrictions on clinical experiences and other changes were finally lifted in the latter part of 2022. The impact of COVID is still felt but the College was able to return to a more familiar experience for students.

St. Joseph's College of Nursing graduated 182 students in the past year: 91 graduates from the Class of December 2022 in the evening/weekend option and 91 from the Class of May 2023 in the weekday option. The associate degree in applied science (A.A.S.) with a major in nursing was conferred on graduates in both options. Some graduates in the Accelerated Dual Degree Partnership in Nursing (A-DDPN) option also earned a Bachelor of Science degree from Le Moyne College. The College of Nursing was able to return to the in-person graduation celebrations that encourage family and friends to share in the accomplishments of the students. St. Joseph's College of Nursing congratulates all students on their graduation and commend their perseverance, resiliency, and commitment to nursing that was steadily demonstrated.

The Commitment to Nursing celebrations were also conducted in person in September 2022 for the weekday program and March 2023 for the evening/ weekend program. This ceremony is traditionally held about halfway through a nursing program and marks the student's commitment to the profession of nursing.

The National Council Licensure Examination (NCLEX-RN[®]) is a nationwide examination for the licensing of nurses in the United States and Canada. St. Joseph's College of Nursing graduates achieved an 81% overall year to date first-time pass rate in 2022. While this number reflects a decline in NCLEX scores, the rate mirrors a decline experienced across all jurisdictions during the height of the COVID pandemic. St. Joseph's scores are still well above state and national means. We are very proud to share that over 60% of the graduates from the Class of December 2022 and May 2023 accepted positions at St. Joseph's Health Hospital.

St. Joseph's College of Nursing presents scholarships and awards in recognition of students Commitment to Nursing celebration and Graduation. From June 30, 2022, through July 1, 2023, a total of \$187,623 was presented to award recipients. These scholarships and awards are made possible from generous alumni and donors of the college.

St. Joseph's College of Nursing was founded by the Sisters of Saint Francis in 1898; the first class graduated in 1900. Since its founding, health care has seen a tremendous advancement in medicine, nursing knowledge, scientific theory, and technology. College students learn to practice the profession of nursing with caring, reverence, compassion, integrity, vision, and enthusiasm. The 125th Anniversary of St. Joseph's College of Nursing as an institution of higher education was celebrated in October 2023. As we continue to celebrate our quasquicentennial anniversary, we recognize the impact that our outstanding graduates make by providing culturally competent care to patients in our community and beyond for the past century-and-a-quarter.



SCHOLARSHIP RECIPIENT MADISON THOMAS ENJOYS PROVIDING COMFORT TO PATIENTS

As a seven-year-old, Madison Thomas declared she was going to be a neurosurgeon. As she grew older and learned more about various health care professions, she realized what she really wanted to do was to care for patients at the bedside.

Today, Thomas is a second-year student at St. Joseph's College of Nursing with plans to pursue either psychiatric or neurology nursing. "I really like connecting with patients, talking to them about their home situation and what brought them to the hospital," she says.

Thomas says her nursing education is preparing her well and she will be ready to enter the profession come graduation next spring. She plans to remain in Syracuse to work, hoping to stay at St. Joe's if she pursues psychiatry.

"I like the population here, the patients and the caregivers," she says. "Everyone is dedicated to providing the best care possible."

THE AUXILIARY OF ST. JOSEPH'S HEALTH HOSPITAL

The Auxiliary of St. Joseph's Health Hospital is an organization of approximately 300 men and women dedicated to serving the needs of St. Joseph's Health Hospital. The Auxiliary dates back to the establishment of the Hospital and has proudly served the institution throughout the years.

In 1869, moved by the need to care for those who suffered from the diseases of the time and desiring to extend their aid to the poor, five Sisters of the Third Order of St. Francis purchased a dance hall and saloon on Prospect Hill in Syracuse, NY for \$12,000. On May 6 of that year, the Sisters opened the doors of St. Joseph's Hospital, then a 15-bed facility with a yearly payroll of \$100. It was Syracuse's first hospital.

Along with the city's first hospital came the formation of the first hospital Auxiliary. Mrs. Hannah Pease, a physician's wife, recognized that the Sisters needed linens for the Hospital. In 1870, Mrs. Pease, along with 45 other dedicated women, formed the Ladies' Aid Society. They met in their homes to sew bed linens and patient hospital gowns. This group became the nucleus of the Women's Auxiliary, officially formed in 1888 and is now known as The Auxiliary of St. Joseph's Health Hospital.

154 years later, the Auxiliary still exists to benefit St. Joseph's Health Hospital. This Volunteer Board of Directors currently has more than 25 committees, including fundraising and service projects. Fundraising efforts have provided the Hospital with an annual monetary gift from the Auxiliary with amounts, since formal record keeping began in the 1990's, totaling over \$9 million. Most recently, for the 2022-23 year, the Auxiliary Gift to the Hospital was \$90,000.

The Auxiliary Board Members are honored and dedicated to carry out its historical mission:

- To promote and advance the welfare of St. Joseph's Health Hospital by addressing the needs of this institution by responding to the Administration in any and every way possible.
- To promote and advance the Mission of St. Joseph's Health Hospital by rendering assistance and service to the Hospital and its patients in any manner approved by the Hospital's Board of Trustees.



As stewards of the St. Joseph's Health system, the Auxiliary supports the following services and initiatives:

OPERATION BACKPACK

More than 800 backpacks were donated to children at their annual physical exams at their annual physical exams at Primary Care Centers Family Medicine Main, Dental, West Pediatrics, Specialty Services, West Family Medicine, and Mental Health James Street locations. The thousands of notebooks, paper, pens, pencils, rulers, tissues, folders, and crayons were donated by the caring colleagues of St. Joseph's and members of the Auxiliary. This marked the 17th year of the Auxiliary's participation in the Operation Backpack Program, with more than 12,000 backpacks having been filled through this initiative.



SISTER WILHELMINA SCHOLARSHIP

The Sister Wilhelmina Scholarship Fund's purpose is to provide an annual tuition scholarship on a competitive basis for St. Joseph's College of Nursing. The scholarship is given in memory of Sr. Wilhelmina who was appointed Director of the School of Nursing in 1943. She was named Treasurer and Administrator of St. Joseph's Hospital in 1951. 51 applications were received, the largest number of applicants in a few years. Eight recipients were selected. A 3.0 grade point average (GPA) must be maintained each semester for the scholarship which is presented at the Annual Luncheon.

THE CARE AND SHARE CLOSET

This initiative continues to serve patients who are in need of new clothing and shoes upon their departure from St. Joseph's Health Hospital's Emergency Department. Auxilians continued to donate to this fund throughout the year.

MEMBERSHIP

The Membership dues letter was mailed in the Fall of 2022 along with an Auxiliary bookmark which lists the major accomplishments of the Auxiliary throughout the years. The bookmark was sent to Life Members of The Auxiliary of St. Joseph's Health Hospital as a thank you from the Auxiliary.

SISTER MARY OBRIST SCHOLARSHIP

The Sister Mary Obrist Scholarship was awarded to a student attending St. Joseph's College of Nursing. In May 2009, The Auxiliary of St. Joseph's Hospital established a full scholarship to be awarded annually to a student in the Dual Degree partnership Nursing Program (DDNP). The Scholarship was named in honor of Sister Mary Obrist who formerly served as Vice President of Support Services of the Hospital. To be eligible for the scholarship and to maintain it, the applicant must have a 3.0 GPA or higher upon completion of his/her first year of study at Le Moyne College.

THE ELLEN NEEDHAM PEDIATRIC NEEDS FUND

This fund honors the memory of Ellen Needham, daughter of Dr. and Mrs. Dwight Needham, who passed away in 1948. Donations are received from those who wish to memorialize someone who has passed or honor someone who is living. The annual Mass was canceled this year due to COVID-19.



COAT DRIVE

Learning of the need for coats for school aged children in the Syracuse community, the Auxiliary created an initiative throughout the system. Hundreds of new and gently used coats were donated and in turn gifted to children in need. The Auxiliary plans to make this an annual ongoing event.

HOLY GROUNDS COFFEE SHOP

The Holy Grounds Coffee Shop serves the patients, public and staff, under the management of St. Joseph's Health Hospital Nutritional Services. Proceeds will continue to be part of the Auxiliary's annual gift to the Hospital.



PRIMARY CARE CLINICS

These Clinics provide medical, emotional, and social expertise for families. The Main Clinic focuses on expectant mothers and those with gynecological needs. The Westside Clinic serves families from pregnancy through adulthood. The Auxiliary Board offers help through donations of clothing, especially warm winter hats, gloves and socks as well as layette items. A special collection of these items and new books are collected during the holiday season.

THE GIFT SHOP

Under a management agreement with Lori's Gifts, yet still overseen by the Auxiliary, Lori's Gifts continues to serve our patients, visitors and staff. All proceeds benefit the Auxiliary and are part of the Auxiliary's annual gift to the Hospital.

TEEN VOLUNTEER RECOGNITION AWARD

The Auxiliary Board celebrated four teens who volunteered during the 2022 summer months at St. Joseph's Health Hospital. In accordance with St Joseph's Health core value of Stewardship, the Teen Volunteer Recognition Award was presented in August 2022. Selected individual(s) were recognized for zealously supporting both the Auxiliary and the Hospital in fulfilling the St. Joseph's Health mission. An application for this award is included in the in-service Teen packets at the beginning of the summer. The selection process is managed by the Volunteer Services Coordinator, with the help of an Auxiliary Board representative and an adult volunteer.

VOLUNTEER LUNCHEON

The 2022 Volunteer Luncheon took place in October at the Bella Domani restaurant and recognized many volunteers collectively celebrating over 37,000 hours of service to St. Joseph's Health. The theme of the luncheon was "Thank you for your Thyme," a notable play on words, but heartfelt gesture, thanks to the creativity of many Auxiliary members and Director of Volunteer Services.

SPRING RAFFLE

This year, the Spring Raffle was presented at the Annual Luncheon, and raised \$500.

ANNUAL MEETING


